1. Call to Order and Welcome of President

President Judy Astle welcomed everyone in attendance and called the meeting to order at 6:08 PM.

2. Introductions

President Astle introduced the 2022 Golf NB Executive Committee to the Board of Directors representatives and guests. The 2022 Golf NB Executive Committee will consist of.

3. Confirmation of Notice of Meeting

Luke Lacey confirmed that the Notice of Meeting for the 2022 Golf NB Spring Board of Directors Meeting was distributed on March 21, 2022 in accordance with Association By-Laws.



4. Confirmation of Quorum

Luke Lacey confirmed that there were 18 member clubs represented and confirmed that quorum had been established in accordance with Association By-Laws.

5. Approval of Agenda

President Astle noted that a motion was received from Joe Sullivan (Golf NB Vice President) to approve the agenda for the 2022 Spring Board of Directors Meeting as circulated, and the motion had been seconded by Gary Melanson (Golf NB Tournament Committee Chair).

6. Approval of the Minutes of the 2021 Fall Board of Directors Meeting

President Astle noted that a motion was received from Allison Chisholm (Golf NB Course Rating & Handicap Committee Chair) that the minutes of the 2021 Fall Board of Directors Meeting be approved as circulated. The motion was seconded by Leanne Richardson (Golf NB Board of Directors Representative and Board of Directors Representative from the Country Meadows Golf Club).

7. Business Arising from the Minutes

President Astle asked if there was any business arising from the minutes. Having heard none, the meeting continued.

8. President's Message - Golf Canada

President Astle introduced Golf Canada President, Liz Hoffman, and asked her to bring greetings on behalf of Golf Canada.

President Hoffman thanked the President Astle for her invitation and for the kind introduction. Mrs. Hoffman touched on the incredible 2021 golf

season and made note of industry highlights such as increased interest in the game and rounds played in 2021. Moving into 2022, Golf Canada will continue with their expanded focus on the Public Player program and golfer retention strategies with the Golf Is Calling 2.0 campaign.

She noted that in March 2022, Golf Canada announced an envision enhancement to its high-performancestrategy towards a goal of advancing 30 Canadians to the LPGA & PGA Tours by 2032 which is only possible because of the generosity of golf champions who have donated a total of \$30 million toward the strategy. President Hoffman also thanked New Brunswick's Andrew Cook and Andrea Jewett for their \$1 Million donation to the high-performance strategy. The enhanced strategy will accelerate Canada's position in global golf and create more heroes. New Brunswick is proudly represented in this strategy by Louis Melanson who was recently appointed as Assistant Coach for Team Canada.

President Hoffman touched on the accomplishments of First Tee Canada in their initial roll out of the first three chapters in British Columbia, Ontario, and Quebec in 2021.

President Hoffman acknowledged the difficult time that clubs such as Aroostook Valley have faced in



2021 and extends the support of Golf Canada as the club prepares for the upcoming season.

President Hoffman congratulated Golf NB for their efforts and operations over the past year and for their continued efforts in 2022.

9. Greetings - Golf Canada

President Astle introduced Golf Canada Director of Member Services, Ryan Logan, and asked him to bring continued greetings on behalf of Golf Canada.

Mr. Logan offered his thanks and gratitude for the invitation to represent Golf Canada at the Golf NB Spring Meeting and sent regrets on behalf of Kevin Blue, Golf Canada's Chief Sport Officer as well as Laurence Applebaum, Golf Canada's Chief Executive Officer.

Mr. Logan shares the excitement from Golf Canada regarding the start of the 2022 season and the incredible momentum that our sport and industry has moving into the new season.

Highlighted was a staffing change for the Atlantic Provinces, Adam Olivastri has transitioned to a new career and Mr. Logan thanked Adam for his contributions to Golf Canada and extends his best wishes to him in the future. Hannah Elliott will be taking on the CSR role for New Brunswick, Hannah is fully bilingual and had most recently been assigned to working with Golf Quebec.

Mr. Logan extends his best wishes for the 2022 season for all member clubs in the province.

10. Greetings - PGA of Canada Atlantic

President Astle introduced PGA of Canada Atlantic, Executive Director, Lindon Garron, and asked him to bring greetings on behalf of the PGA of Canada Atlantic.

Mr. Garron echoes the comments of President Hoffman and shares that we must all continue to respect our golfers and encourage further participation. The PGA of Canada currently sits at his highest membership levels in the association's history.

The PGA of Canada Atlantic is planning to host a full schedule this year with three events slatted to take place in New Brunswick.

The PGA of Canada Atlantic share Golf Canada's excitement regarding the direction and launch of First Tee in Atlantic Canada.

Mr. Garron touches on the collaboration between the PGA of Canada Atlantic and Golf NB as the two associations look to continue their history of working together to achieve common goals.

11. President's Report

President Judy Astle thanked everyone for attending the 2022 Spring Meeting over Zoom Call.

Golf NB is planning, to run a full championship schedule in 2022 and resume to normal programs and services. President Astle thanked the host facilities for their support.

Golf NB has several championships that are at maximum field capacity and have extensive waitlists. Golf is in a great position, and this has been proven by the increased demand for championships and events.



President Astle asked that club representatives continue to encourage their members to participate in Golf NB events in 2022 and made special note of the return of the NB Under 13 & Under 15 Boys & Girls Championships and the increased registration numbers for the NB Women's Provincials.

She also asked all club representatives to encourage their members to purchase Golf NB / Golf Canada individual memberships in 2022.

12. Presentation of 2021 Audited Financial Statements

Ms. Leslie Knox of Teed Saunders Doyle provided an overview of the 2021 Audited Financial Statements. Ms. Knox thanked the Golf NB team for their assistance which allowed for a smooth audit process.

Ms. Knox is happy to share that Teed Saunders Doyle will be issuing an unqualified or clean auditors report once again in 2021.

Ms. Knox presents the DRAFT Audited Statements to the group.

Overall, the association saw a revenue increase of \$76,000 over 2020 largely due to an increase in membership dues and entry fees. The increased activities in 2021 led to an increase of \$82,716.00 in expenses related to travel and programs and services.

Together this results in an excess of revenue over expenses in operations of \$90,243.00 for 2021 which is very consistent with 2020. The association is once again showing a very strong year for 2021.

President Astle noted that a motion was received from Kathy Greenbank (Golf NB Finance Committee Chair) that the 2021 Golf NB Audited Financial Statements be approved as presented. The motion was seconded by Joe Sullivan (Golf NB Vice-President).

Motion Carried

President Astle thanked Ms. Knox and the staff at Teed Saunders & Doyle, for their work in preparing the 2021 Audited Financial Statements.

13. Presentation of 2022 Golf NB Annual Budget

For the information of those in attendance, Golf NB Finance Committee Chair, Kathy Greenbank, provided an overview of the association's 2022 budget that had been previously approved by the Golf NB Executive Committee.

Mrs. Greenbank highlighted revenue items such as membership fees, grants, investment income, sponsorships and entry fees for Golf NB events and championships.

The executive committee has made the decision to allocate \$30,000 from the associations' surplus to Development initiatives in 2022 as part of a three-year commitment.

Mrs. Greenbank noted that administration and tournament costs continue to be the largest expenses for the association.

14. Committee Reports

President Astle noted that the chairs of each of Golf NB's Standing Committees had prepared a report, which had been previously circulated as part of the meeting's report booklet. President Astle asked if



there were any questions for the respective Committee Chairs on their reports prior to moving on with the agenda.

Past President, Peter Hyslop voices his comments and concerns regarding recommended By-Laws. Due to technical difficulties the group was unable to hear Mr. Hyslop's comments.

Board of Directors Representative for Aroostook Valley, April James shares an updated with the group on the activities of the club via the chat function. "Depending on weather and the condition of our private access road, AVCC's best case for opening will be May 5th. Check out our website for access to the course. US residents will be required to come through a Canadian port of entry with the ARRIVECAN app and must access the course as Canadians do. At this stage there will be NO access to AVCC from the club's parking lot by US or Canadian residents."

15. Golf NB Update

Golf Executive Director, Luke Lacey, provided an overview of Golf NB activities and areas of focus for 2022.

Mr. Lacey touches on the momentum that Golf NB is carrying over from 2021. Unique challenges such are increased tournament registrations have added new complexities to operations for this season but touches on how it is a good problem to have.

Golf New Brunswick is excited to welcome back Audi Moncton and Royale as partners for 2022 while also welcoming BrokerLink and Wacky's Flooring to the associations growing family of passionate partners.

The association is proud to have expanded to 49 member facilities across the province. Gilridge Golf Club, Par94 and Top Shots Golf are the latest facilities to join as Golf NB and Golf Canada Members. Golf NB is continuing to drive more value to attract more members and are hopeful to continue growing the association.

L. Lacey extends his thanks for the support from Golf Canada, Golf NB Member Facilities, the Golf NB Board of Directors and the Executive Committee.

J. Sullivan thanks L. Lacey for his efforts since taking on the role in September 2021.

16. Golf Canada Update

Jeffrey Hutt provided a high-level review of 2021 along with some key areas of focus for 2022. Mr. Hutt thanked Adam Olivastri for his contributions to Golf Canada and specifically New Brunswick. Jeff will be working with Hannah Elliott to assist with her transition to working with New Brunswick and Atlantic Canada.

Mr. Hutt reminded clubs that membership renewals will be coming up for all facility members. In 2021 all membership renewals were pushed back to June 1st, and clubs should be aware that these renewals are going to be coming up shortly. Hannah Elliott (Coordinator Golf Services, Golf Canada) will be contacting facilities to help facilitate the renewal process in the coming weeks.

Mr. Hutt took some time to speak to some of Golf Canadas primary areas of focus in 2022 which include.

- First Tee / Junior Golf Programs
- Membership Growth / Member Club Resource Page
- Enhancements to the Golf Canada website and mobile application



17. First Tee Atlantic Presentation

Mr. Colin Gillis, Manager of First Tee Atlantic provides a presentation on First Tee Atlantic and the areas of focus for 2022.

18. Election of the Golf Canada Provincial Council Representative

Allison Chisholm noted that annually Golf NB must elect a person to serve as its representative on the Golf Canada Provincial Council for the following year. As per By-Law 13, Ms. Chisholm nominated Judy Astle as Golf NB's Provincial Council Representative for the 2023 year.

The nomination was seconded by Leanne Richardson (Golf NB Board of Directors Representative and Board of Directors Representative from the Country Meadows Golf Club).

31. Rapport de la présidente

Golf NB prévoit organiser un championnat complet en 2022 et de reprendre ses programmes et services habituels. La présidente Astle remercie les installations hôtes de leur soutien.

32. Présentation des états financiers vérifiés de 2021

Mme Leslie Knox, de Teed Saunders Doyle, donne un aperçu des états financiers vérifiés de 2021. Mme Knox remercie l'équipe de Golf NB de son aide qui a permis un processus de vérification sans heurts.

Mme Knox est heureuse d'annoncer que Teed Saunders Doyle produira de nouveau un rapport de vérification sans réserve en 2021.

Mme Knox présente au groupe l'ébauche des états financiers vérifiés.

Dans l'ensemble, l'association a vu ses revenus augmenter de 76 000 \$ par rapport à 2020, en grande partie grâce à l'augmentation des cotisations des membres et des droits d'entrée. L'augmentation des activités en 2021 a entrainé une augmentation de 82 716,00 \$ des dépenses liées aux déplacements et aux programmes et services.

Il en résulte un excédent de recettes par rapport aux dépenses de fonctionnement de 90 243 \$ pour 2021, ce qui est très cohérent avec 2020. L'association affiche une fois de plus une année très solide pour 2021.

President Hoffman extended a massive thank you and recognition for Andrew Cook and Anne Jewett for their contributions made to Golf Canada and their endowment of the Young Pro Players of the Year.

2021 saw the initial launch of the First Tee Canada Program with chapters opening in British Columbia, Ontario, and Quebec. The targeted launch of the First Tee Atlantic Chapter is 2022 once the \$1 Million USD donation had been secured.

President Hoffman highlights the progress that Golf Canada has made in Diversity, Equity and Inclusion and Safe Sport with both staff and board enhancements in 2021, showcasing the organizations commitment to change.

Golf Canada is excited and optimistic for 2022 with plans to host a full Amateur and Professional Championship Schedule.

Golf Canada Chief Executive Officer, Laurence Applebaum then took a moment to acknowledge the efforts of President Astle and the Golf NB Executive, and attendance and efforts, of Jeff Hutt, Regional Director, Atlantic, Ryan Logan, Director, Membership, and Adam Hunter, Director, Grow the Game, Golf Canada.

Mr. Applebaum also recognized the 12 years that Mr. Tyson Flinn was the leader of Golf NB as Executive Director. He was considered an incredible asset to Golf Canada and Golf NB.

Mr. Garron applauded Golf Canada and Golf NB for their efforts to help support the industry growth experienced by facilities and the game of golf in general in 2021.

Mr. Lacey directed the meetings attention to his report which was previously distributed. Mr. Lacey then thanked all of those in attendance particularly the special guests from Golf Canada and the PGA of Canada.

Mr. Lacey extends his thanks to all Golf NB club operators and owners for their efforts in 2021 and support throughout the season.

Mr. Lacey also mentioned his appreciation and thanks for the Golf NB Executive Committee and Provincial Volunteers for their efforts and contributions to ensure Golf NB's programs and services can operate at full capacity.

10. Approval of Committee Reports

Joe Sullivan moved to approve the reports as circulated. Seconded by Malcolm Angus

Motion Carried.

11. Golf Canada Update

Golf Canada Regional Director, Jeffrey Hutt, provided an overview of 2021 membership activities in New Brunswick.

He noted that rounds played are up significantly in 2021, and that rounds posted are set to eclipse 2020 totals. The increase in rounds played is also translated into increases in club memberships both Provincially and Nationally.

Mr. Hutt provided an overview of membership numbers both nationally and provincially and indicated that "Public Player" memberships are up significantly in 2021.

Priorities for 2022 will be focused on membership growth and Mr. Hutt will be working with Luke Lacey to achieve further growth.



Incident protection program in 2021 showed a greater value to members with 45 claims in NB, up from 22 in 2020 amounting for a total of roughly \$20,000.

Mr. Hutt takes a moment to highlight the Membership Agreement between Golf Canada and Golf NB from the Report Booklet. The signed agreement begins in 2022 till 2024 and established both Individual Membership and Public Player Membership Fees for those years. He then goes on to highlight the reasoning behind the agreement as Golf Canada looks to achieve parity across the country with their portion of membership fees whether its being purchased in British Columbia or New Brunswick.

Mr. Hutt echoed Mr. Garron's comments, and thanked Mr. Flinn, for his efforts over the last 12 years and for first hiring Mr. Hutt at Golf NB in 2010 and help set Mr. Hutt on his career path. Mr. Hutt also extends his thanks to Luke Lacey, Lindon Garron and the Atlantic Allied Group for their partnership and Collaboration.

Golf Canada Director, Grow the Game, Adam Hunter, provided a presentation on the First Tee Canada and Update on Atlantic Chapter activities for the group.

Mr. Hunter extends his thanks to the Golf NB Executive and President Astle for the invitation to participate at the 2021 Golf NB Annual General Meeting.

Mr. Hunter provides a background on First Tee, a world leading youth development organization founded in 1997 and a globally recognized brand. First Tee Canada launched in 2021 with chapter in BC, ON and QC and plans to be fully operational in all provinces by early 2022 – including First Tee Canada Atlantic. The chapters require a \$1 Million USD gift to launch.

The First Tee Canada Program is delivered through three channels – Schools, Community Centers and Golf Facilities. The Program is offered to Junior Golfers ages 5-18 with program locations serving between 25-75 golfers.

Mr. Hunter mentions that with the generous support from RBC, Golf Canada has launched the RBC Community Junior Golf Program. This program is the accelerated implementation of First Tee and Youth on Course at Municipal Golf Courses across Canada.

Mr. Hunter provides the group with an update on the First Tee Canada Atlantic Chapter. He confirms that Golf Canada and First Tee have secured the \$1 Million USD chapter founding gift and staff recruitment has commenced. Operations are scheduled to begin in Q1 2022 with the chapter launch being done in close collaboration with the four Atlantic Provincial Associations.

Mr. Joe Sullivan poses a question for Mr. Hunter regarding the RBC Community Junior Golf Program. Mr. Hunter clarifies that the RBC Program is designed to engage municipal and highly accessible public golf facilities.

12. Appointment of Auditors for 2022 fiscal year

Kathy Greenbank moved that the firm of Teed Saunders Doyle be appointed as auditor for 2022 Fiscal Year. Seconded by Andrew Cook.

Motion Carried.

13. Appointment of members of the Board of Directors

President Astle confirmed the appointment of Leanne Richardson of the Country Meadows Golf Club and Shaun MacDonald of the Gowan Brae Golf & Country Club as Board of Directors



Representatives on the Golf NB Executive Committee for 2022.

14. Election of officers for the 2022 year – Tom Hendershot

Tom Hendershot presented the Nominating Committee Report. In accordance with Article X-(3) of the General By-Law of the New Brunswick Golf Association the Nominating Committee consisted of the three immediate past presidents and includes Martin Boudreau, himself and Allison Chisholm.

Le directeur régional Golf Canada, Jeffrey Hutt, fournit un aperçu des activités des membres en 2021 au Nouveau-Brunswick.

Il note que les rondes jouées ont connu une hausse importante en 2021 et que les rondes affichées pourraient éclipser le total de 2020. Cette augmentation se traduit par une augmentation des adhésions des clubs, dans la province et au pays.

M. Hutt fournit un aperçu du nombre d'adhésions à l'échelle provinciale et nationale et indique que les adhésions « membres du public » ont connu une hausse importante 2021.

En 2022, nos priorités seront l'augmentation du nombre de membres; M. Hutt travaillera avec Luke Lacey pour atteindre cette croissance.

En 2021, le programme de protection contre les incidents s'est avéré d'une grande valeur auprès des membres : 45 réclamations au N.-B., soit 22 de plus qu'en 2020, pour un total de 20 000 \$.

M. Hutt prend un moment pour parler de l'entente entre Golf Canada et Golf NB, de la brochure des rapports. L'entente signée est entrée en vigueur en 2022 (jusqu'en 2024) et établit les frais d'adhésion des membres individuels et des joueurs du public. Il indique la justification de cette entente alors que Golf Canada souhaite atteindre la parité au pays avec leur portion des frais d'adhésion, achetée en Colombie-Britannique ou au Nouveau-Brunswick.

M. Hutt s'est fait l'écho des commentaires de M. Garron et remercie M. Flinn de ses efforts ces 12 dernières années, d'avoir embauché M. Hutt à Golf NB en 2010 et d'avoir contribué à le mettre sur la voie de sa carrière. Il remercie également Luke Lacey, Lindon Garron et l'Atlantic Allied Group de leur partenariat et de leur collaboration.

L'administrateur de Golf Canada et responsable du programme Grow the Game, Adam Hunter, fait une présentation sur le First Tee Canada et une mise à jour des activités de ce groupe en Atlantique.

M. Hunter remercie le conseil de direction de Golf NB et la présidente Astle de l'invitation pour participer à l'AGA 2021 de Golf NB.

M. Hunter présente le contexte de First Tee, un organisme de développement jeunesse de premier ordre fondé en 1997 et une marque reconnue mondialement. First Tee Canada a été lancé en 2021 avec des divisions en Colombie-Britannique, en Ontario et au Québec, et on prévoit être pleinement opérationnel dans toutes les provinces de l'Atlantique au début de 2022, incluant First Tee Canada Atlantic. Chaque division requiert un don de 1 million \$ US pour être lancée.

Le programme First Tee Canada est offert sur trois canaux : les écoles, les centres communautaires et les installations de golf. Le programme est offert aux golfeurs junior, âgés de 5 à 18 ans, et les emplacements du programme desservent de 25 à 75 golfeurs.

M. Hunter dit que, avec le généreux soutien de la RBC, Golf Canada a lancé son programme communautaire de golf junior RBC. Ce programme est la mise en œuvre accélérée de First Tee et Jeunes sur le terrain, sur les terrains de golf municipaux, partout au Canada.

M. Hunter présente au groupe une mise à jour sur la division First Tee Canada Atlantic. Il confirme que Golf Canada et First Tee ont obtenu le don d'un million de dollars américains pour la fondation de la division et que le recrutement du personnel avait déjà commencé. Les activités devraient prendre leur envol au premier trimestre de 2022, et le lancement de la section se fera en étroite collaboration avec les quatre associations provinciales de golf du Canada atlantique.

- To continue to have more and more male members to want to play in our events. It would be nice to see a need for one day qualifying rounds for the men to take part in in order to compete in Golf NB Championships.
- To increase the number of Rules Referees in the province. If you are interested or if you know someone in your club that may be interested, please submit your name to Luke at the office.
- For Golf NB to continue to grow in all facets. The Strategic Plan that will be addressed later in this meeting holds a lot of EXCITING things for the next 3 years!
- Golf NB is always looking for new members who would like to serve a role on the Board. If you are interested, please submit your name to Luke at the office.

Congratulations to all the Champions of 2022.

Again, I thank you for allowing me the opportunity to be your President for the last three years. It certainly was an experience. I am here to assist the new President, the Board and support to Golf NB as Past President for the next few years.

COURSE RATING & HANDICAPPING REPORT

It was great to see the trend of lots of golf being played continue for 2022. The Golf Canada Score Centre was a buzz all season with a record number of scores being posted in New Brunswick and across the country.

On the handicapping front, Golf NB hosted three Handicap Certification Seminars this spring for our member clubs. The first took place on Saturday, February 26th, Tuesday, March 23rd, and Sunday, April 24th. As of this meeting, over 90 % of our clubs have completed this process. We have also certified over 50 individual members in the process. Please remember that as part of the Handicap Licensing agreement with the World Handicap Authority (WHA), each club must have at least one member complete the handicap certification process and have a handicap committee. We will be scheduling more certification seminars through the winter to get everyone ready for the 2023 golf season. We would also direct you to the Golf Canada website for the on-line version of the seminar (that you can complete at any time): Golf Canada Handicap Certification Seminar - YouTube. This presentation is available in English and French.

The Golf NB and Golf Canada websites provide many resources to aid in educating your members about the World Handicap System. There are posters, short videos, and other articles to assist in making sure that the handicap system is effectively administered throughout our province. Golf Canada also has a video that focuses on the changes to the Rules of Handicapping in Canada. The General Presentation goes through each of the changes by comparing the pre-2020 system and the new Rules of handicapping while also providing explanations and rationale for each change. It is still available on the Golf Canada website, although we will be migrating to a presentation that only teaches the World Handicap System in the coming year. The video is available in English and French.

The other significant part of the process with the World Handicap Authority is that each member club must sign a license agreement. Golf Canada signs an overall agreement with the WHA, each of the provinces signs an agreement with Golf Canada and each club signs a licensing agreement. We were able to streamline this process and provided an on-line/electronic option to complete the document through Docu-sign. As of this meeting, over 90% of the clubs have completed this process. We have contacted the remaining clubs and they should be compliant in the coming weeks.



We would like to mention that there is only one authorized handicap provider in New Brunswick. As part of the membership to Golf Canada/Golf NB, the members clubs and individual members have access to the Golf Canada Score Centre. If you are using other software to calculate your handicaps they are not authorized and may not be accepted from clubs when entering events around the province. If you have any questions, please contact the Golf NB office for further information.

Golf NB would like to remind the member clubs that one additional service that we can provide is the allocation of handicap stroke holes. Historically, this process was a club function and followed the guidelines in Section 17 of the Golf Canada Handicap System. The process was completed by using score cards from players in differing handicap ranges to determine the 'hardest hole' or what we like to call 'where the higher handicap player requires a stroke to half the hole'. As an additional option to the clubs, the WHA Course Rating Program will generate a summary of the stroke hole allocations based on the difficulty of the rating obstacles and using a system of triads to assign the strokes evenly across the 18 holes. It is meant as an additional choice for the assignment and is not meant to replace the process chosen by the club. It is recommended that each member club provide at least one handicap stroke hole allocation version for each gender (normally calculated from the most frequently played tees).

The National Handicap & Course Rating Committee has also provided a guidance document for the Provincial Golf Associations on the establishment of par. Under the World Handicap System, par is much more important as it is part of the calculation of course handicaps as well as the calculation of Net Double Bogey and Net Par. There are guidelines in the Rules of Handicapping for assigning par and the province will be able to assist with those holes that fall into the overlap of the guidelines. Both, the stroke hole allocation and establishment of par will be added to the process when your course is rated, however, if you are interested in reviewing these for your club please contact us.

As for Course Rating, through some great work of our volunteers (and some help from our Nova Scotia raters – in a joint rating) we were able to complete the ten ratings on the schedule for this year: Gilridge, Aroostook Valley, Covered Bridge, Mactaquac, Gage, Pine Needles (Pine and River), Royal Oaks, Country Meadows, and St. Ignace.

Course Ratings for 2023 are tentatively scheduled for Hillsborough, Pokemouche, Edmundston, Gowan Brae, Lakeside, Plaster Rock and Restigouche.

The National Handicap and Course Rating Committee met a number of times throughout the year with some important agenda items including, the establishment of par, updates to the Golf Canada Score Centre, creating a Club Handicap Committee Tool kit, revision of the Course Rating and Handicap Certification subsidy program, creating an education matrix for course rating and handicapping, certification of course raters, and using the Score Centre to identify those certified in Rules and Handicapping. As part of the work done by the national committee, we are looking at providing training



for those interested on a national basis and regional calibration sessions to allow more local raters to attend the sessions.

The WHA-Course Rating Subcommittee has also met once over the last season with a number of interesting agenda items including the process for measuring golf courses, providing provisional course ratings for those countries that do not have the process complete, confirming the course rating changes made in 2020 and confirming any changes for the 2024 cycle, the certification of course raters, altitude adjustments for bogey women, transgender golfers and other potential changes to the binary system, and research on short courses and non-traditional courses. Despite the delays caused by covid, countries around the world continue to make the transition to the WHA.

Have a wonderful winter and we will see you again in the spring.

POLICY REVIEW REPORT

It has been two and a half years to arrive at the point of presenting to you an update to our By-Laws. Our due diligence has included multiple reviews with input from the Executive Committee, a Golf Canada review and three legal reviews.

SUMMARY BY-LAW CHANGES

Naming Conventions

<u>Board of Directors</u> - name change to Member Representatives or Membership. Why-currently the "named" Board of Directors do not act as Directors, they act as representatives of our member clubs, therefore the name change is reflective what they do and who they represent.

The Board of Directors provide direction and oversight to the staff which is what the Executive does today.

In addition, there are fiduciary responsibilities under the New Brunswick Company act that is not a reasonable expectation of our member representatives. So, by changing the naming conventions we have placed that responsibility with the Executive.

Executive- name change to reflect the positions within the Board of Director's. President, VP, Treasurer/Finance Chair.



Board of Directors- currently Executive and Committee Chairs.

Binary Terminology- remove any he/she, his/her references.

<u>Secretary</u>- revised wording reflects the opportunity that this position can be two different individuals and it provides flexibility for the Association going forward. For instance, <u>if</u> we ever went to a 3 person staff the Secretary role could be separate from the Executive Director role.

<u>Treasurer-</u> similar rational as it is currently our Finance Chair but provides some flexibility in the wording.

Committee

Naming the standing committees reflect committees that will always be required. Personnel, Finance and Nominating. All others are operational and are not required to be in the By-Laws. Rules, Handicap, Course Rating, Policy, By Law and Strategic Initiative related committees will be considered operational and ad hoc. Keeping in mind if a committee is named in the By-Laws, then we must have them up and running. Keeping the majority Ad Hoc ensures we are not going up against what we say we do in the By-Laws.

Membership-Member Clubs

Provides clarity, reflects changes in our members (Simulator sites) and clearly outlines who has a vote.

Number of Directors

Small change in recommending a slightly smaller minimum and lower maximum. 6 and 11. Being only a 2 staff Association anymore is too many and fewer than 6 is not effective.

Term Limits for Directors

Its important to have a turnover rate at the Board level to encourage new ideas, differing points of view while also maintaining a level of knowledge and understanding of how the administration of our sport functions. We believe these term limits accomplishes both.

Annual General Meeting

Our AGM will move to the Spring. Appointing new Executive in November places inexperienced and first time Executives in a position to be less effective. November is when the budget process begins, December is annual review of staff and January is the year end process. Moving the appointments to Spring allows 6-7 months to become familiar with staff, processes, and policy. For an Executive the heavy lifting is November to May.



NEW-Safe Work-Universal Code of Conduct

Providing a Golf NB version for Safe Work & Code of Conduct policy was the easy part. Many sport organizations have these in place, including our National Governing Body, Golf Canada.

The difficulty for us is ensuring all member clubs adhere to the policy and for certain, while hosting a Golf NB event. Considering the recent news cycle involving Hockey Canada, it is in everyone's best interests that we ensure our member facilities are aware of our Safe Sport and Code of Conduct Policies. The incident itself is unconscionable, the fact the incident occurred during the Associations Foundation Gala which included a golf outing should give us all some pause. Although our tournament season is over for the year, you should review whether you have the proper safeguards in place and, your role in ensuring your facility is adhering to the Policies.

Golf New Brunswick (Golf NB) benefitted once again from the committed efforts of its office staff.

Golf NB Staffing Update – In May 2022, Golf NB welcomed Jared Legacy to its full-time staff as Administration Manager. Jared's knowledge of the industry and eagerness proved to be invaluable during his first season with Golf NB.

Golf NB was also fortunate to secure the services of Alex Vanderlaan, who served as both Golf NB's Summer Administrative Assistant and Summer Tournament Coordinator. Alex was a valuable asset to Golf NB this summer and we wish him all the best as he returns to UNB for his final year of study.

Golf NB 2 for 1 Card Program - The 2022 Golf NB 2 for 1 Card program was the most successful years in the history of the program. This year's program included 26 participating clubs from across the province. A total of 2,075 cards were ordered with 1,740 distributed to Partner Clubs and 335 cards sold in house.

With the success of the program in 2022, we look forward to the 2023 program which will feature 28 of our Partner Facilities. Golf NB is excited to welcome the Mountain Woods Golf Club, and the Hillsborough Golf Club to the program for the upcoming year. Membership Update – As of November 1, 2022, Golf NB partner facilities have activated **7,999** individual members, which represents an increase of **591** members over 2021. This represents an increase of **7.7%** over the total number of members activated by Golf NB partner facilities in 2021.

To date, there are 30 facilities who have increased individual memberships over 2021, with 7 of those facilities having increased their membership activations by greater than 50 members over 2021.

If we consider **Public Player** sales, as of November 1, 2022, Golf NB & Golf Canada have activated a total of **8,663** individual members, equaling 117% of our 2021 total members.

The Golf NB family of partner facilities grew in 2022 as we welcomed two facilities back to our association while also welcoming two new facilities.

Golf NB is proud to have 50 dedicated partner facilities across the province which now includes:

- Hillsborough Golf Club Hillsborough, NB
- Gilridge Golf Club Fredericton, NB
- Par94 Golf Fredericton, NB
- **Top Shots Golf** Saint John, NB

In 2021, Golf Canada began conversations with all Provincial Associations (PAs) to review the existing membership splits as well as investigate the possibility of achieving parity and equity with respect to membership rates across the country. The goal of the exercise was to ensure the Golf Canada portion of individual membership fee was equal for all members across the country by 2024, meaning that a member in St. John's remits the same amount to Golf Canada as a member in Victoria. After many positive conversations, Golf Canada was able to achieve agreements with all PAs across the country. As a result, the impact for New Brunswick and its partner facilities will as follows:

2023 - \$38.50 per individual membership

2024 - \$41.00 per individual membership

2023 - \$60.00 per Public Player Membership

2024 - \$60.00 per Public Player Membership

Golf NB & Golf Canada have made significant enhancements to the suite of benefits led by a new app, new website, and upgrades to the digital experience through the Golf Canada Score Centre to name a few. Golf NB and Golf Canada would like to thank you

NEW BRUNSWICK GOLF ASSOCIATION, INC.

GENERAL BY-LAWS

1. BUSINESS NAME(S)

New Brunswick Golf Association, Inc. (the "**Association**") may operate under any business name(s) as may be approved by the Board of Directors (the "**Directors**" or the "**Board**") and permitted under the laws of New Brunswick.

2. HEAD OFFICE

The Association's head office will be located in Fredericton, New Brunswick, or at such location as may be determined from time to time by the Board.

3. FISCAL YEAR

The Association's fiscal year shall terminate on December 31st each year.

4. SEAL

The corporate seal of the Association shall be in the form impressed in the margin hereof. The corporate seal shall not be used except for authority of a duly approved resolution of the Board or the membership. The seal shall be kept at the head office of the Association.

5. MEMBERS

- 5.1 Eligibility Any formally organized golf club or golf operation shall be eligible for membership in the Association upon making written application, agreeing to the conditions of the Association's constating documents (including these By-Laws and any policies implemented by the Directors from time to time) and paying the annual membership dues assessed by the Association from time to time, which shall include dues assessed by Golf Canada or any successor association.
- 5.2 Membership Categories The Association's membership shall include the following 3 categories of membership, with only Category 1 Members and Category 2 Members having voting rights:
 - <u>Category 1 Members</u>: any golf club that has members who pay annual fees to that golf club or a
 golf course that offers other methods of payment to those individuals who have the intent of
 playing regularly on that course.
 - <u>Category 2 Members</u>: any golf operation that is open to the public, but which has no Category 1
 Members. For clarity, a single premises may be used for the operations of multiple Category 2
 Members.
 - <u>Category 3 Members</u>: any person not otherwise a Category 1 Member or a Category 2 Member that has paid a fee to and received services from Golf New Brunswick and/or Golf Canada. For clarity, Category 3 Members shall have no voting rights in relation to the Association's affairs.
- 5.3 Membership Dues Membership dues shall be determined by the Board of Directors and approved by the Membership at the fall meeting of member clubs as outlined in the Membership Policy.



- 5.4 Payment of Membership Dues Dues shall be invoiced to each Member annually and paid forthwith to the Association. In any year, if the Association has not received full payment of membership dues, the non-paying Member may be subject to interruption of services and or further penalties as outlined below.
- 5.5 Non-Payment of Membership Dues The Board shall be entitled to suspend or, alternatively, expel a Member for non-payment if annual dues are not paid in full by September 1st each year.
- 5.6 Suspension or Expulsion from Membership All Members shall be bound by these By-Laws and the rules and decisions from time to time of the Board. Any Member that fails to comply with these By-Laws and policies of the Board shall be subject to suspension or expulsion from membership in the Association. Suspension or expulsion from the Association shall require positive votes by at least 75% of the Directors. No Member shall be suspended or expelled without due notice, together with full particulars of the reason for the suspension or expulsion, and the Member shall be given the opportunity to be heard by the Board prior to suspension or expulsion.
- 5.7 Appeal A Member that has been suspended or expelled from membership in the Association may appeal the Board's decision in that regard at a special meeting of the Members.
- 5.8 Reinstatement In the event of a Member's suspension or expulsion, the Member may apply for reinstatement by remedying the event which gave rise to the suspension or expulsion and submitting to the Board a written request for reinstatement.
- 5.9 Withdrawal A Member may withdraw from the Association at any time by providing the Association with written notice of its intention to withdraw. For clarity, any Member that withdraws from membership in the Association gives up the rights and privileges of membership in both the Association and Golf Canada.

6. MEETINGS OF MEMBERS

- 6.1. Members shall have at least 2 regular meetings per year: the Fall Meeting; and the Annual General Meeting.
- 6.2. The Annual General Meeting shall be held at such place within New Brunswick, at such time not later than the 15th day of May in each year, as may be determined from time to time by the Directors. In addition to any matters required under the *Companies Act* (New Brunswick), the agenda for the Annual General Meeting shall include:
 - call to order;
 - confirm due notice of the meeting was given and that a quorum is present;
 - approve minutes of the last Members' meeting;
 - present annual reports of officers, Directors, and committee chairpersons;
 - report of the Nominating Committee; and
 - present and approve of audited financial statements and auditor's report of the Association for the previous fiscal year;



- present and approve of the proposed budget;
- such further business as may properly come before the meeting and for which notice has been duly given.
- 6.3. The Fall Meeting of the Members shall be held at such place within the Province of New Brunswick at such time not later than the 15th of December in each year as may be determined from time to time by the Directors. The agenda for the Fall Meeting shall include:
- call to order;
- confirm due notice of the meeting was given and that a quorum is present;
- approve minutes of the last Members' meeting;
- present reports of officers, Directors and committee chairpersons;
- appoint an auditor;
- such further business as may properly come before the meeting and for which notice has been duly given.
 - 6.4. Special Meetings of the Members may be called by the President or the Board upon the written request of at least 5 Members. Written notice stating the time and place of the Special Meeting and a description of the business to be discussed at the Special Meeting shall be communicated via email to each Member at least 14 days prior to the date of the meeting.
 - 6.5 Notice of Meeting: Notice of the time and place of any Members' meetings shall be sent at least 14 days prior to the holding of such meeting. Any notice may be duly given to the Members using the email address of each Member as shown in the Association's records and by posting notice on the Association's website.
 - 6.6. At every meeting of the Members, a Member may have in attendance 1 or more persons associated with it. To be officially represented at any Members' meeting, the Member shall select 1 representative associated with it who shall be authorized by it and entitled to vote on behalf of such Member on all matters which may come before any such meeting.
 - 6.7 A representative of a Member must be a member of the relevant golf club or operation, as applicable.
 - 6.8 Participation by Electronic Communication Facilities: Any Member's representative may attend and participate in any meeting of Members by means of telephone, virtual or other communications facilities that permit all persons participating in the meeting to hear each other. A Member's representative participating in a meeting by such means shall be deemed to be present at the meeting.
 - 6.9 Voting Procedures: At any meeting of Members, each Category 1 Member and Category 2 Member shall, through its selected representative, be entitled to 1 vote. Category 3 Members shall not be entitled to vote.



6.10 Quorum: Representatives of 8 Members shall constitute a quorum at any meeting of the Members of the Association, but a lesser number may adjourn a meeting to a stated time and place.

7. DIRECTORS

- 7.1. The management of the affairs of the Association shall be vested in the Board of Directors, who shall have the power to act and supervise all the affairs of the Association including, but not limited to, the power to incur indebtedness, authorize expenditures, set dues, organize tournaments, and affiliate with other associations, including Golf Canada and other provincial associations.
- 7.2. The Board shall be comprised of not less than 6 and not more than 11 Directors. The Board shall consist of the President, the Vice-President, the immediate Past President, and Directors at large that may act as the chair of a standing or operating committee or zone representative. All individuals on the Board, except the Past President and 2 Directors appointed by the President shall be elected at the Annual General Meeting of the Members.
- 7.3 The nomination of individuals for election to the Board shall be carried out by the nominating committee pursuant to its terms of reference and nominating procedure.
- 7.4 Each Director's term of office shall be for 2 years from the Annual General Meeting at which they were elected or until their successor is elected.
- 7.5 In case of a vacancy on the Board, for any cause or reason, the Board may appoint an individual to fill the vacancy. A person appointed by the Board to fill a vacancy shall hold office until the next Annual General Meeting. (Excluding the President).
- 7.6 Each Director shall be limited to serving not more than three (3) consecutive terms as a Director, provided that terms during which a person serves as President or Past President will be excluded from such calculations.
- 7.7. A Director may be removed from office before the expiration of their term if they cease to be a member of a Category 1 Member or a Category 3 Member, or if there is a resolution in favour of the Director's removal adopted by 75% or more of the Members at a duly constituted meeting of the Members.
- 7.8. Persons who have long service in the Association may by resolution of the Board be admitted to honorary life membership in the Association. Any Life Member shall have the right to attend all meetings of the Association and shall have a deliberative voice therein but shall have no right to vote.
- 7.9 No remuneration is to be paid to the Board, but a Director shall be entitled to reimbursement for travelling and other expenses related to any services undertaken at the request of the Board.

8. MEETINGS OF DIRECTORS



- 8.1 The Board shall meet at least 6 times during the calendar year. The President or any 2 Directors may at any time call a meeting of the Board.
- 8.2 Notice of Meeting: Notice of any meeting of the Board shall be given to each Director by email at least 10 days before the meeting.
- 8.3 At any meeting of the Board, a simple majority of Directors shall form a quorum for the transaction of business.
- 8.4 Questions arising at any meeting of the Board shall be decided by a majority of the votes. In the case of an equality of votes, the chairperson shall have the tie-breaking vote.
- 8.5 Any Director may attend and participate in any meeting of the Board by means of telephone or other communication facilities that permit all persons participating in the meeting to hear each other. A Director participating in a meeting by such means shall be deemed to be present at the meeting.

9. OFFICERS

- 9.1 The officers of the Association shall consist of the President, the Vice-President, the Secretary and the Treasurer. The office of Secretary and Treasurer may be held by the same person. The officers of the Association shall be elected by the Directors and confirmed/approved by the Members at each Annual General Meeting to serve a term of 2 years or until their successors are elected. All officers shall be subject to removal with cause by resolution of the Board at any time.
- 9.2 No remuneration is to be paid to the officers of the Association, but an officer shall be entitled to reimbursement for travelling and other reasonable expenses incurred in performance of the officer's duties.
- 9.3 In case of absence of the President, the Vice-President or of any other officer of the Board, or for any other reason that the Board may deem sufficient, the Board may delegate from time to time the powers of such officer to any other officer or any Director, provided that a majority of the Board concur therein.
- 9.4 The President shall be the Chief Executive Officer of the Association and shall:
 - be an ex-officio member of all committees of the Association;
 - preside at meetings of the Board;
 - act as chairperson at all meetings of the Members of the Association;
 - sign all instruments which require signature of the President;
 - perform all duties incident to the office;
 - have such powers and duties as may from time to time be assigned to them by the Board.
- 9.5 The Vice-President shall be vested with all the powers and shall perform all the duties of the President in the absence or disability or refusal to act of the President. The Vice-President shall have such other powers and duties as may from time to time be assigned to them by the Board.



9.6 The Secretary shall:

- issue or cause to be issued notices of all meetings of the Members and of the Board;
- have charge of the minute and membership record books of the Association;
- have custody of the corporate seal of the Association;
- exhibit the minute and membership books of the Association to any Director upon request;
- sign with the President or other signing officer or officers of the Association such instruments as may require their signature; and
- have such other powers and duties as may from time to time be assigned to them by the Board.

The Board may delegate all or portions of the duties of the Secretary from time to time to the Executive Director of the Association, if applicable.

9.7 The Treasurer shall:

- have supervision of the financial affairs and carry out the financial policies of the Association;
- before the end of each fiscal year, prepare and present to the Board a proposed budget of expenditures for the ensuing year, recommending specific appropriations for each standing or other committee:
- have the care and custody of all funds and securities of the Association and shall deposit same in the name of the Association in such bank or banks or with such depositary or depositaries as the Board may direct;
- exhibit the financial books and accounts to any Director upon request;
- sign or countersign such instruments as require their signature;
- have also such other powers and duties as may from time to time be assigned to them by the Board:
- serve as chairperson of the Finance Committee;
- perform all duties incident to their office or that are properly required of them by the Board.
- 9.8 Executive Director: The Executive Director shall perform all duties as may be determined or instructed from time to time by the Board.

10. GOLF CANADA PROVINCIAL COUNCIL REPRESENTATIVE

- 10.1 The Board shall nominate a Director to represent the Association on the Provincial Council of Golf Canada. Although not mandatory, there is a desire to have the Association's President be the Provincial Council of Golf Canada Representative.
- 10.2 The Provincial Council Representative will be elected annually by the Members.

11. COMMITTEES



- 11.1. The Association shall have the following standing committees:
 - Finance Committee:
 - Personnel Committee;
 - Nominating Committee.
- 11.2 The President shall appoint annually the chairperson of all standing committees from the Directors. Members of each committee shall be appointed by the President and/or the chairperson of each committee. Terms of reference for each committee shall be revised and approved by the Board.
- 11.3 All Directors shall have a vote, but where individuals are serving on the Board in more than 1 capacity, they shall only be entitled to 1 vote. At the invitation of the President, additional individuals may be invited to attend specific meetings of the Board, but these additional individuals may not vote.
- 11.4 Further ad hoc or special committees may be appointed by the Board from time to time for a special task and shall be dissolved automatically on the completion of the task and the submission of a written report.

12. FINANCES

- 12.1. The Association will have 1 budget that will cover all the Association's programs and services.
- 12.2. The Association will maintain a minimum of 1 bank account.
- 12.3. All cheques for Association business will be issued from the Association's bank account.
- 12.4. The banking business of the Association or any part thereof shall be transacted with such chartered bank, trust company, or other firm or corporation carrying on a banking business as the Board may designate, appoint or authorize from time to time by resolution and all such banking business, or any part thereof, shall be transacted on the Association's behalf by 1 or more officers and/or other persons as the Board may designate, direct or authorize from time to time by resolution and to the extent therein provided including, but without limiting the generality of the foregoing, the operation of the Association's accounts, the making, signing, drawing, accepting, endorsing, lodging, depositing or transferring of any cheques and promissory notes, acceptances, bills of exchange and orders for the payment of money, the giving of receipts for and orders relating to any property of the Association, the execution of any agreement relating to any such banking business and defining the rights and powers of the parties thereto, the authorizing of any officers of such banker to do any act or thing on the Association's behalf to facilitate such banking business.

13. AUDITORS

At the Fall Meeting of the Members, an auditor or auditors shall be appointed for the purpose of examining and verifying all books, vouchers, and accounts of the Association. The Auditors shall report thereon with a statement of income and expenditures after the close of each fiscal year in accordance with Canadian Accounting standards for not-for-profit organizations.



14. CONTRACTS

All contracts, obligations, deed, or transfers on behalf of the Association shall be signed by the President or Vice-President and also by the Secretary or Treasurer, and where required the corporate seal shall be affixed to such instruments. The Board may, notwithstanding any provisions to the contrary, appoint a Director as an additional signatory by whom any instrument or instruments, contract or contracts, obligation or obligations may be executed.

15 INDEMNITY & NON-LIABILITY

15.1 Each Director of the Association shall assume office on the express understanding, agreement and condition that every Director of the Association shall from time to time and at all times be indemnified and saved harmless out of the funds of the Association from and against all costs, losses, charges and expenses whatsoever which such Director sustains or incurs in or about any action, suit or proceeding which is brought, commenced or prosecuted against the Director or in respect to any act, deed, matter or thing whatsoever made, done or permitted by the Director about the execution of their duties, and also from and against all other costs, losses, charges and expenses whatsoever, including travelling expenses, which the Director sustains or incurs in or about or in relation to the affairs of the Association, except such costs, losses, charges, or expenses as are occasioned by the Director's own willful neglect or default. No Director of the Association shall be liable for the acts, receipts, neglects or defaults of any other Director or officer or employee of the Association or for joining in any receipt or act for conformity or for any loss, damage or expense happening to the Association through the insufficiency or deficiency of title to any property acquired by order of the Board for or on behalf of the Association or for the insufficiency or deficiency of any security in or upon which any of the money, of or belonging to the Association shall be placed out or invested or for any loss or damage arising from the bankruptcy, insolvency or tortious act of any person, firm or corporation with whom or which any monies, securities or effects of the Association shall be lodged or deposited or for any other loss, damage or misfortune whatsoever which may happen to the Association in the execution of the duties of the Director's respective office or in relation thereto unless the same shall happen by or through the Director's willful neglect or default.

15.2 The Association shall not indemnify a Member, Director, officer, committee member or any other person unless the person acted honestly and in good faith with a view to the best interests of the Association.

15.3 The Association shall purchase and maintain such insurance for the benefit of its Members, Directors, officers and committee members as the Board may determine appropriate from time to time.

16. AMENDMENTS

These By-Laws may be amended, repealed, or re-enacted by the approval of 2/3 of the Board, with the provision that they shall be approved at the next meeting of the Members or at any Special Meeting thereof, provided that the notice outlining the proposed changes shall have been given to Members at least 30 days before the date of such Members' meeting. An affirmative vote of at least 2/3 of the voting Members present at such meeting shall be required to pass the changes.
