MEMBERSHIP POLICY

The purpose of the Membership Policy is to describe the membership and invoicing policies and procedures of the New Brunswick Golf Association (hereby referred to as Golf NB or Association for the remainder of this policy) for the use of the Board of Directors, Member Club Representatives, Executive Director, and the other volunteers and employees of Golf NB.

Information contained herein may be reviewed from time to time but shall be reviewed every year by the Executive Director. These policies, which have been reviewed by the Executive Director, and approved by the Board of Directors Golf NB, may be amended from time to time between regular reviews and such amendments shall become effective immediately upon approval by the Board of Directors.

The Executive Director of Golf NB shall be responsible for the implementation of membership policies.

Membership Categories are defined in Golf New Brunswick (Golf NB) By-laws Section V.

Golf NB and Golf Canada invoice for all member facilities as outlined below.

Facility Members are encouraged to activate and/or renew accounts for all members. 'Members' are — individuals, who purchase a season pass, pay a fee to your facility: shareholders, corporate members, full members, members of the junior/men/women or senior's sections.

FACILITY MEMBERSHIP

The facility membership dues structure as of **November 01, 2022, to October 31st, 2023**, is as follows:

36-hole facility: \$1,440.00
27-hole facility: \$1,150.00
18-hole facility: \$860.00
9-hole facility: \$570.00

Indoor or Driving Range facility*: \$250.00

*Does not meet the requirements for an official rating



INDIVIDUAL MEMBERSHIP

Golf NB invoices for all individual club members who are registered on the facility's member roster (Golf Canada Score Centre) with a portion to be remitted back to Golf Canada.

Individual dues for those that are members of a facility who wish to join Golf NB / Golf Canada are to be collected by the facility and remitted in conjunction with the schedule below.

The club member individual dues structure as of **November 01, 2022, to October 31st, 2023**, is as follows:

• Individual Club Member: \$38.50

Individual memberships are available to any golfer who wishes to join the association through Golf Canada's Public Player program which is administered through Golf Canada's website and paid directly to Golf Canada.

The individual dues structure as of **November 01**, **2022**, **to October 31**st, **2023**, is as follows:

• Individual Public Member: \$59.99

Individuals must be a fully paid member in good standing in order to participate in any Golf NB or Golf Canada tournament or event.

INVOICING & PAYMENTS

The payment schedule for facility dues will be as follows

Invoice #1 - June 1

- Golf NB / Golf Canada Facility Fee
- Total number of individual memberships activated between November 1 and May 31

Invoice #2 - August 1

• Additional individual memberships activated between June 1 and July 31

Invoice #3 - November 1

Additional individual memberships activated between August 1 and October 31

As per Association By-Laws, failure to receive payment by the deadline will result in the suspension of the member services including golfer access to the Score Centre (handicap system). A Facility Member, who has not paid its annual dues by the deadline, will be deemed a non-member and will no longer receive Golf NB services until payment is received in full. Membership in Golf NB for the following year will require payment of the outstanding invoice from the previous year.
